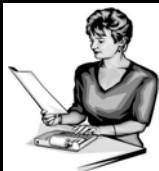

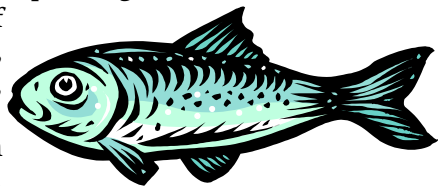

**H**erring is a much under-appreciated fish in the U. S. So much so that many of the standard cookbooks, such as Better Homes and Gardens New Cook Book, Betty Crocker's Cookbook, and The Fanny Farmer Cookbook, do not include any recipes for preparing the fresh fish. Herring is not even listed in their indices.

In Europe, particularly northern Europe along the Baltic and North Sea coasts, herring is an important part of the local cuisine. In many countries, Scandinavia, Germany, and Briton, they are a staple of the diet.

Aside from the Baltic and North Sea stocks, herring, a cold water fish, can be found on both sides of the Atlantic as far south as the north of France and the Chesapeake Bay. Herring from different oceans or seas form different subspecies or races, which vary slightly from one to another. Herring is a fatty fish and one of the most nutritious and cheapest fishes available, which make them ideal for pickling or canning. Their unpopularity as a fresh fish may be because of their many small bones. Fresh herring is rarely seen in the markets in the U. S. If you can find any, the simplest way to prepare them is to clean them, scale and remove the heads, split them and carefully remove the spine with most of the bones. The smallest bones that are left will soften with cooking and can be left in. Then spread olive oil over them and grill. They also can be sautéed or fried in a small amount of olive oil, in which case, onions and tomatoes can be sautéed along with the fish. The Scots coat them with oatmeal before frying.

In Europe, where fresh herrings are more readily available, there are many more elaborate recipes available. André Simon lists such delicacies as



Savory Herrings, Herrings B la Bordelaise, and Herrings B la MeuniPre. If you are cooking fresh herrings for the first time, I recommend simple grilling or sautéing so that you can get the full delicious flavor of the fish.

Most of the herrings caught are salted or brined to preserve them. The preserved herrings are then pickled, canned, or smoked. Cold smoked herrings become the kippers of British breakfast fame. The canned variety of kippers that is available in the U. S. is only an unworthy substitute for the true British kipper.

Canned herring in tomato or mustard sauce is often sold in the U. S. as sardines. Maine "sardines", caught off of Canada or New England are immature herrings.

Most herring ends up pickled in Europe and the U. S. The number and variety of pickled herring are almost endless. The traditional Swedish smorgasbord may have as many as twenty varieties of herring on it. A herring plate, often served as an opening course in a formal dinner, would have from three to six varieties (five as served on the QE2). The most common kinds of pickled herring are:



*marinated herring*  
*marinated herring with sour cream*  
*spiced herring*  
*herring in mustard sauce*  
*herring with garlic*  
*herring in tomato sauce*  
*herring in curry sauce*  
*herring in wine sauce*  
*matjes herring*  
*glassblowers' herring*  
*sustromming*  
*sotare*  
*Bismark herrings*  
*Rollmops*  
*schmaltz herring*

In spite of not being a common food item in America, two uses of herring have entered our lexicon. From the British, the "red herring" that was dragged across the track of a fox to distract the hounds and now denotes a diversionary tactic, is a kipper. A well smoked kipper is reddish brown in color. Clementine's "herring boxes without topses", which served her for shoes, came packed with dried salted herrings that would keep unrefrigerated for forty-niners sustenance.

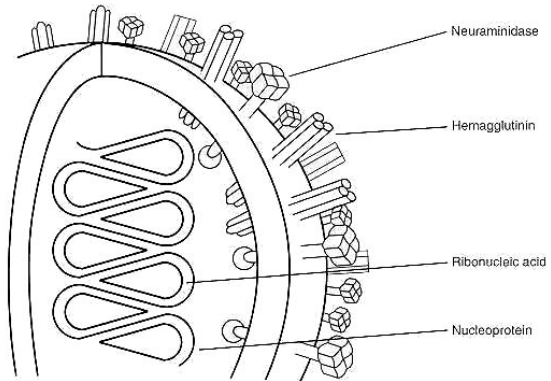
## Influenza

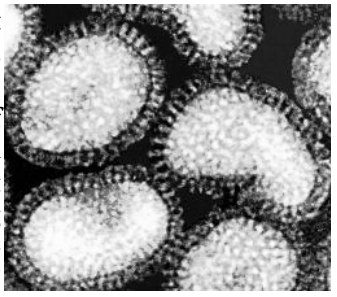

Influenza is a contagious viral disease usually referred to as “the flu”. Hippocrates was the first to describe a flu-like disease in 412 BC. The Roman historian Livy described an influenza-like disease that struck the Roman army in 212 BC. The word “influenza”, derived from an Italian word meaning influence, was first used in 1357 when people believed that the disease was caused by the influence of the stars. The first epidemic in Europe is said to have occurred in 1173, with outbreaks continuing throughout the centuries to the present. An epidemic is a contagious disease that spreads rapidly among individuals living in a specific area. An endemic disease is one that is under control. A pandemic disease spreads beyond the confines of an area, affecting an entire nation, continent, and even spreading worldwide. The first worldwide influenza pandemic occurred in 1580 when bloodletting was a commonly used treatment. Since that time, influenza pandemics have occurred at a frequency of once every 9 to 39 years. Pandemics in the 20<sup>th</sup> century have occurred in 1918 (Spanish flu), 1957 (Asian flu), 1968 (Hong Kong flu) and 1977 (Russian flu). The 1918 pandemic was the most deadly with 20 million deaths, more than the number that died as a result of World War I combat.

A virus is a tiny biological infectious agent, about a millionth of an inch in length, which varies in shape and complexity. A virus must have a host cell on which to live and replicate, as it does not have its own enzymes to carry on these functions. There are 3 types of influenza viruses, A, B, and C. Type C causes only mild respiratory symptoms. Type B causes very few epidemics, and is not generally a serious problem except in elderly or debilitated persons. Type A affects humans, birds, and mammals, and has a potential to cause epidemics and pandemics. This is because Type A undergoes frequent changes. Its surface is covered with 2 kinds of antigens (proteins), hemagglutinin (H) and neuraminidase (N), referred to as spikes. There are approximately 500 H spikes and 100 N spikes. H helps the virus attach to and enter a host cell, and N destroys the host cell and helps the offspring escape to infect other cells. The H spikes have specific receptor binding proteins which look for specific receptor sites on the host cell to which they



attach. A human virus will not usually affect an animal or plant cell, and vice versa. This is because the receptor binding proteins on the virus must specifically match the receptors of the host cell or they cannot attach and cause a disease. Receptors on other animal or plant forms will not match human receptor binding protein. If the surface H and N remained constant, immunity could be built up, but H and N



are constantly mutating. These changes are referred to as antigenic drift and antigenic shift. "Drift" is the slow small constant changes that occur on the surface over time. "Shift" refers to an abrupt change in the surface proteins. These occur much less frequently and result in new H and N proteins. The evolved viruses can affect new hosts or new species. Antibodies are proteins that form in the presence of antigens to fight an invasion of viruses or other invading organisms. Antibodies form as the result of having a disease or being immunized against a disease. An antibody will attach to the receptor binding protein of the virus or other disease-producing antigen, and render it harmless, as it can no longer bind to a host cell. Type A flu viruses are divided into subtypes based on the differences in the H and N. Some examples of these are A(H1N1), A(H1N2), A(H2N2), A(H3N2), etc. If a person who once had A(H1N1) flu and developed antibodies against those viruses, later contracts A(H1N2) flu, he will get the flu again but he has some protection against the H1 component. If he contracts A(H2N2), he has no protection against either, and may become very ill. Each year a flu vaccine is prepared based on predictions from the Centers for Disease Control (CDC). Each flu vaccine contains three strains of purified inactivated (killed) influenza virus, two A type and one B type. The CDC reports a 70% to 90% efficacy rate in preventing influenza or in reducing the severity of an outbreak in healthy persons less than 65 years of age when the vaccine and circulating viruses are antigenically similar. Efficacy rates are less in the elderly because of "decreased immunologic response" in that age group. Anyone over the age of 6 months can receive a flu shot. The flu shot is the best method to prevent the flu, and is especially recommended for people over 65, adults and children with chronic diseases as cardiovascular, respiratory, or metabolic problems, and residents of nursing homes or other institutions. Health care workers are also encouraged to have flu shots because of their high numbers of patient contacts. It takes two to four weeks to begin an antibody response to a flu shot. It is important to receive a flu shot between October and November so you will be protected by the start of flu season, usually between November and March in the United States. Getting the flu shot in December, or even later, will still offer you some protection.

Influenza is spread by respiratory droplets from coughing or sneezing, and enters the body via mucous membranes of the nose, mouth, or eyes.

Incubation period is 1 to 4 days and the contagious period lasts from one day before onset of symptoms till about five days after onset. Children are contagious for a longer period of time, up to 6 days before onset of symptoms. Symptoms of influenza are often confused with those of the common cold. Symptoms for both colds and flu include congestion, runny nose, headache, cough, or sore throat. Influenza has a more sudden onset of these symptoms, and also includes fever, aches and pains, and fatigue. If you contract the flu, get bedrest, drink plenty of fluids, and take acetaminophen for aches and pains or fever. Antibiotics are not effective treatment for viruses. Most flu symptoms dissipate within a few days, though cough and fatigue may remain up to two weeks. Influenza can worsen other health problems, especially in the elderly. Pneumonia is a possible complication so it is advised that persons over 65 also consider a pneumonia vaccine. People who are allergic to thimerosal or eggs are advised not to receive the flu shot. Thimerosal is a preservative containing mercury and eggs are used as the medium to grow the virus for the vaccine. Adverse reactions to the flu shot are rare and are usually only redness at the site of injection. You cannot get the flu from a flu shot because it is not live virus.

Several medications are available to help prevent or control influenza. Antiviral agents work by interfering with the reproduction cycle of viruses. If administered in the first day or two of onset of symptoms, these medications may reduce the duration of influenza. N inhibitors prevent the invading virus from leaving the host cell, which halts the infection, causing the virus to die within the cell. These medications are not meant to be a substitution for the flu shot, which is still the best protection you can give yourself.

There are new types of vaccines and antivirals being developed. A nasal spray, claimed to be 93% effective, may be released in 2003. Preventing the spread of influenza is an attainable goal. Get a flu shot each year.

**F**or those few who actually read this column on a monthly basis, hearken ye back to March 2002. At that time I related to you the story of Emory University history professor Michael Bellesiles, author of the book "Arming America: The Origins of the National Gun Culture". In his book he proposed that, contrary to popular belief and prevailing historical perspective, the America of the Founding Fathers was not a nation where firearms had much, if any, importance in the lives of the colonials. He claimed to have reviewed over 11,000 probate records from 40 counties, and that his research showed that less than 7% of all colonial homes kept a firearm, or owned one in working condition, and that since gun ownership was so rare among early Americans, even on the frontiers, no one would have cared enough about the right to give it constitutional protection.

For his efforts, Prof. Bellesiles received fame and acclaim from the liberal left, as well as from academia (sorry for being redundant), where he was awarded the prestigious Bancroft Prize in American History and Diplomacy from Columbia University. It was touted by left-leaning legal scholars and history professors around the country as the beginning of the end for Second Amendment protections, and as proof positive that the Second was never a right of the individual.

At about the same time as the release of his book, Prof. Bellesiles and 46 other law professors and historians sent a harsh letter to Charlton Heston, president of the National Rifle Association. They told him "the Second Amendment permits broad and intensive regulation of firearms" and urged him to move beyond such unimportant concepts such as constitutional guarantees to "the real issue": how much regulation is needed to "prevent the killings and violence that plague our country today."

Mr. Bellesiles always claimed that his book wasn't political. But the letter suggests otherwise. Clearly his fellow scholars on the left saw "Arming America" as the best thing to happen to their cause in years. At least three signers would write glowing reviews of "Arming America." Five others would write glowing intros for its cover; one of them, Michael Zuckerman of the University of Pennsylvania, joyfully describing Mr. Bellesiles as the "NRA's worst nightmare." Another would sit on the very committee that gave Mr. Bellesiles the prestigious Bancroft Prize.

Garry Wills in the New York Times Book Review wrote: "Bellesiles deflates the myth of the self-reliant and self-armed virtuous yeoman of the Revolutionary militias." Edmund Morgan in the New York Review of Books expounded that: "He (Bellesiles) has the facts. No one else has put them together in so compelling a refutation of the mythology of the gun."

However, another group of scholars, including Jim Lindgren of Northwestern, Gloria Main of the University of Colorado, Randolph Roth of Ohio State, Robert Churchill of the University of Hartford, and many

more, all experts in the historical detail on which Mr. Bellesiles based his research (probate records, militia counts, homicide rates), produced a mountain of evidence showing the book to be irredeemably flawed. However, for taking scholarship seriously they were largely ignored, and even chastised, by many of those Second Amendment "scholars" who so desperately wanted Bellesiles's work to be right.

Although the proof of his misrepresentations and outright fabrications became more widely known, his defenders from the academic left continued to ignore it. Mr. Zuckerman was quoted in *The Nation* just this month saying that "the critics are casting about for a way to discredit" Mr. Bellesiles. Mary Beth Norton of Cornell (a letter signer) claimed in the same piece that Mr. Bellesiles's work was "just as plausible" as that of his critics.

When the *William and Mary Quarterly* asked four scholars to evaluate "Arming America," three wrote damning reviews. The fourth, Stanford's Jack Rakove (also a letter signatory), chose to look not at the book's accuracy but at what the thesis meant for the Second Amendment. In an interview, he still maintained that the book, while flawed, "raises interesting questions."

However, evidence has arisen to show that not all honor is dead in academia. An academic panel, composed of scholars from Harvard, Princeton and the University of Chicago, has reviewed "Arming America" and accused Mr. Bellesiles of "unprofessional and misleading work." The panel's report goes on to say Mr. Bellesiles' failure to produce his research documents or to interpret those that do exist accurately "does move into the realm of falsification."

Even some supporters have seen the light. One of the signers of the letter, Stanley Katz of Princeton, ultimately sat on the above panel. Another, Saul Cornell at Ohio State, stated "the committee did a thorough job. Michael has had a chance to respond, and their criticism is very persuasive."

And finally, in a spin that even Bill Clinton's supporters would admire, Mr. Bellesiles tendered his resignation to Emory, saying he "cannot continue to teach in what I feel is a hostile environment."

Columbia University, however, has not yet revoked the Bancroft Prize that they awarded for "Arming America", nor has Bellesiles returned it, so there is still ample evidence that the liberal mindset still can believe that there is no need for facts in a "factual" treatise.

I wonder if Mr. Heston will ever receive a letter from those same "scholars" about how his and the NRA's efforts to sustain a constitutional right have been the driving force in the preservation of an American tradition and way of life?

About as likely as seeing unbiased honesty out of the politically correct liberals in the media and the hallowed halls of academe.

Don't hold your breath.



**My Point of View**

**Justice Denied**

Ever since the “Republican Revolution” of 1994, one of the key items on the conservative agenda is to institute “Tort Reform” to make it more difficult for individuals to sue big businesses. After all, “everyone knows” that the American working class is little more than a bunch of litigation-happy opportunists backed by greedy trial lawyers looking for a free ride at the expense of the business community. After all, look at the \$2.7 million award some old lady won from McDonalds because she spilled some hot coffee on herself!

Yet, is this really the case? Are we common folk really doing in Big Business with our frivolous lawsuits with the multimillion dollar awards? Are we really, as the Tort Reformers suggest, tying up the court system with nonsense suits? Have the courts really been too eager to take away hard-earned business profits and just hand out big amounts to those of us who refuse to accept responsibility for the things we do? For the answer to these and similar questions, one needs only to look at the truth. For starters, let’s look at a couple of these “frivolous lawsuits”:

Let’s begin with that darling of Tort Reformers everywhere, the infamous coffee case, Liebeck v. McDonalds (1994). In February 1992, one Stella Liebeck and her grandson pulled up at an Albuquerque, New Mexico McDonald’s drive thru window and ordered coffee. After picking up the order, the grandson parked the car so Liebeck could add cream and sugar to the coffee. In so doing, Liebeck spilled the coffee on her lap, causing third degree burns covering 6 percent of her body. The coffee was between 180 and 190 degrees, capable of causing such burns in as little as two seconds, and far too hot for consumption. The industry standard for coffee temperature is approximately 155 degrees. Moreover, this was not the first burn case due to McDonald’s excessive coffee temperature – it was learned through discovery there were some 700 prior incidents – and McDonald’s still refused to lower the coffee temperature.

The case begun when McDonald’s refused Liebeck’s claim for about \$20,000 to cover her resultant medical expenses. When she took McDonald’s to court, a jury awarded her \$160,000 in compensatory damages and \$2.7 million in punitive damages, largely due to McDonald’s inaction in the 700 other incidents. Now, for the rest of the story. The trial court reduced her punitive damages to \$480,000; then the parties entered into an undisclosed post-verdict settlement, presumably to avoid appeal by McDonald’s.

Now let’s look at a second case, the drunken woman who drowned. It is claimed that a drunk woman’s estate received \$1 million after she entered a closed city park and drowned in three feet of water. These are the facts in this case: On July 21, 1985, a group of seven people, including 32-year-old plaintiff Ana Garcia, squeezed through a hole in a fence at approximately 1 a.m. to get into a municipal pool in the Bronx. The lights were off and no lifeguards were on duty. Ms. Garcia, who had been drinking and whose blood-alcohol level was later measured at 0.23 percent (twice the legal

limit), stepped into the shallow water, fell beneath its surface and drowned. At trial, the woman's family won a \$2 million negligence suit against New York City, even though the jury agreed that the woman herself was partly negligent for breaking into the pool and trying to swim while intoxicated. The award was later reduced to approximately \$615,000. In October 1994, the Appellate Division of the State Supreme Court threw out the entire award, stating that the woman assumed the risk of her actions and thus was solely responsible for her own death. *Garcia v. City of New York*

Now that we can see that multimillion dollar awards do not necessarily hold up, let's look at the Tort Reformers' other claim that our frivolous lawsuits against Big Business are choking the courts. But is this really the case? According to court records and other sources, it would appear that **businesses want the courts for themselves**. Contract and property cases -- most of which involve businesses -- comprise more than one-third of all civil cases in state courts. By comparison, product liability cases accounted for only 0.21 percent of all civil cases. (National Center for State Courts, 1995). Moreover, business cases account for 47 percent of all punitive damage awards. In contrast, only 4.4 percent and 2 percent of punitive damage awards are due to product liability and medical malpractice cases, respectively. (Rand Institute for Civil Justice, 1996). Businesses suing each other over contracts comprised nearly half of all federal court cases filed between 1985 and 1991. (The Wall Street Journal, Dec. 1993.)

Finally, let's look at some really frivolous lawsuits:

**Hormel Foods**, the maker of the luncheon meat SPAM, sued Jim Henson Productions to stop the creator of the Muppets from calling a character in a new movie "Spa'am." Hormel claimed that the "Spa'am" character represented an unclean, grotesque boar calling into question the purity and quality of its meats. After a full trial, a federal court judge recently rejected Hormel's claims. Hormel appealed, but also lost (*Hormel's case would have been unaffected by a "Tort Reform" bill. But a Hormel worker injured by a defective meat cutting machine might be left without any rights*).

**Pepsi-Co's Frito-Lay** snacks division sued Proctor & Gamble in November 1995 after Proctor & Gamble claimed that its Pringle's Right Crisp potato chips were "more nutritious" than Frito-Lay's chips (*This lawsuit would be unaffected by a "Tort Reform" bill. But a Frito-Lay worker killed by a defective forklift or other machine might be left without any rights*).

**Scott Paper's Canadian division** sued Proctor & Gamble in 1995, alleging that Proctor & Gamble had misled consumers about the absorbent power of Bounty paper towels by advertising it as the "quicker-picker-upper" (*A "Tort Reform" bill would not affect Scott Paper's case. But a lumberjack injured by a defective chainsaw while cutting down the tree used to make paper towels might be left without any legal recourse*).

Given the above, does Big Business really need to be protected from us?
