

***DOGS DON'T KNOW  
IT'S NOT BACON...***

Most Presidential election years I find people of this Country still have no idea how the whole thing works. What would happen if the candidates from the two major parties died while campaigning? The only place to go for the answer to this and any other question about the election process is to check out the real electors of the President and Vice President of the United States of America (because it surely is not the average person on the street), the Electoral College. <http://www.fec.gov/pages/ecworks.htm>.

There is nothing in the Constitution or any of our other governing documents stating we must have candidates from the two main political parties to have an election – the two parties we have now bear little resemblance to the early political parties from the formative years of this Nation, so these parties would not have been identified as the only valid political parties for this country. In fact, since we do not vote for the President directly, it is immaterial if there is even a candidate name listed. Some States would print the names of all of the Electors associated with a candidate, but that confused people so most just have: “electors for (Candidate Name)” because they do not want to lie to the American public.

Contrary to popular belief, therefore, we do not have a two party-system, Democratic and Republican. A person can be a valid candidate for President without the backing of any political party and there are several smaller but nonetheless valid parties running candidates. We are not merely tolerant of these “misguided souls who refuse to be categorized as a Democrat or Republican”; it is completely legal for these parties to present candidates (and, most importantly – electors to the Electoral College). Therefore, no purpose is served by not holding an election, even if the candidates for the two biggest parties are lost to some disaster. In fact, that would be against the Constitution.

As mentioned before, the ballots used to show all of the names of the electors who had sworn to vote for a particular candidate. All but two States use the “winner takes all approach” for sending Electors to the College, the other two states divide the numbers by percentages for each candidate. The Electoral College must have a clear-cut majority of votes for the President and Vice-President or the election is then turned over to the House of Representatives. There are date limitations when all of this voting and such must take place.

Electors for a candidate in one party can vote for a candidate in another, there is nothing to prevent this. If we had only to count the numbers of Electors garnered by each Candidate, we would not have to wait until December for the final vote from the Electoral College. Delegates to the Nominating Conventions would sometimes switch sides (because the Electors can do so) but that has been stopped by most States. However, the Electoral College rules did not change at the same time so the Electors are still able to vote as self-determined.

The process gets confusing to a lot of voters as they cannot sort out the

difference between the Conventions and the Electoral College. The Electoral College can vote more than once before turning over the election to the House. The Electors are not sworn so much to a candidate as they are to a party...hence a nominated candidate who cannot for some reason continue can be replaced without the nominating process having to be redone.

To interrupt the elections in this Country would require disrupting the College Electors on the day they are to cast their ballots, not the nominating process. Too bad the talk show hosts were sleeping during Civics class or they would know this.

Interestingly enough, the Electors vote separately for President and Vice-President. Hence, there is an unlikely chance of a President from one party and a Vice-President from another being elected together.

**T**wo weeks ago I wrote about what the Securities and Exchange Commission was doing to regulate the mutual fund industry to help the small investor, the “poor folks”. It really added up to zero. Now the SEC is going to make new regulations for hedge funds to protect the rich folks. And it is more window dressing. In fact, it looks downright stupid. When I say rich folks it is because in order to qualify to invest in a hedge fund you must have assets of one million dollars and income of \$200,000 per year for a single person and \$300,000 for a couple. With this kind of money you can hire an attorney or financial expert to read the hedge fund document. Furthermore, the major investors in hedge funds are not little investors, but pension plans, endowments and universities that are supposed to be administered by professionals.

The SEC says they want to put in regulations to help prevent fraud. Hey, you guys, what about all the fraud you did NOT find in the regular mutual fund industry? They missed multimillions of fraud in standard “poor folks” mutual funds and now they want regulations to protect the rich folks. All this will do is create more useless expensive jobs in Washington. Every time you hire a new government worker it is the same as putting more tax on everyone, rich and poor.

The Senate Banking Committee voted it in by a 3 to 2 committee decision. Three Democrats for and 2 Republicans against. It is the usual liberal Democrat who wants “feel good” legislation that does no good, but tells the public “we care”. Such expensive nonsense. And how are they going to put this new regulation into effect? More paperwork without question. The funds would be required to hire a Compliance Officer who would write out a set of trading procedures and a code of ethics. Because I have owned a regulated brokerage company I can tell you this is a pile of BS. The new compliance officer is paid by management. He is a toothless tiger. And the SEC will come to do an on-site audit every 2 to 5 years. Because my company was in Florida they did not show up until January or February.

What is most interesting is that there were only 46 hedge fund fraud cases during the past 5 years involving about one billion dollar. In an industry with more than \$800 billion in assets this is a spit. Let the rich folks sue and don't burden us “poor” taxpayers. This new regulation means nothing and is merely a first step for more stringent rules to follow. It is another additional cost of doing business and adds to our taxes.

**Bush II: The  
"Taliban Candi-  
date"?**

"WAR IS PEACE  
FREEDOM IS SLAVERY  
IGNORANCE IS STRENGTH"

George Orwell, 1984

All too often, life imitates the movies and vice-versa. Certainly, the last 3-1/2 years under the Bush II regime bears this out. Back toward the latter part of June, I went to see Michael Moore's Fahrenheit 9/11. During the same time frame, I had been reading Craig Unger's most informative book, House of Bush, House of Saud. Both the movie and the book focused on the too-close ties that have existed for decades between America's most powerful family and the ruling family of Saudi Arabia. Both suggest that these ties seriously conflict with America's vital interests, including, but not limited to national security.

What was most eye opening, however, are the close business ties between the Bushes and the Bin Ladens. Is it too much of a stretch to suggest that this puts the relationship between the "Wartime President" and the tragedy of September 11, 2001 in a whole new light? For that matter, could there be any sort of alliance between our modern conservative movement that proposes to force upon fellow Americans their brand of Christian values and the radical Islamic Jihad movements that appear bent on destroying those 'infidels' who do not wish to subscribe to their brand of morality?

What follows are some interesting and, to me, disturbing, facts. The following passages relate to Bush II's 2000 Presidential campaign:

*"The close relationship between the two great dynasties was not the only factor that might interfere with Bush's acting against the growing terrorist threat. Republicans had just woken up to the fact that there were roughly 7 million Muslims in America ... Bush campaign strategist Grover Norquist came up with an aggressive plan to win them over by making alliances with groups run by Islamic fundamentalists. ... As the president of Americans for Tax Reform, Norquist was a founding member of the Islamic Institute, a nonprofit foundation promoting Muslim political movements. ... the Republicans could make the case that Bush's ties to the oil lobby made him more receptive to Arab and Muslim concerns." (1)*

*"On March 12, 2000, Bush and his wife, Laura, met with more Muslim leaders at a local mosque in Tampa, Florida. Among them was Sami Al-Arian, a Kuwaiti-born Palestinian who was an associate professor of engineering at the University of South Florida. ... Sami Al-Arian vowed to campaign for Bush—and he soon made good on his promise in mosques all over Florida. ...*

*But Al-Arian had unusual credentials for a Bush campaigner. Since 1995, as*

*the founder and chairman of the board of World and Islam Enterprise (WISE), ... Al-Arian had been under investigation by the FBI for his associations with Islamic Jihad ... Al-Arian brought in Ramadan Abdullah Shallah, ... to be the director of WISE. A strong advocate of suicide bombing against Israel, Shallah was allegedly responsible for killing scores of Israelis in such attacks.” (1)*

The following passages relate to the terrorist threat and the relevant Bush Administration policies in the months prior to the September 11 attack:

*“On April 18, U.S. Airlines got a memo from the FAA warning that they should demonstrate a ‘high degree of alertness’ because Middle Eastern terrorists might try to hijack or blow up an American plane. ... Likewise, beginning in May, over a two month period, the National Security Agency reported ‘at least thirty-three communications indicating a possible, imminent terrorist attack.’” (2)*

*“... In May, Colin Powell announced that the United States was actually giving \$43 million to the Taliban because of its policies against growing opium. (1)*

*“Enslave your girls and women, harbor anti-U.S. terrorists, destroy every vestige of civilization in your homeland, and the Bush Administration will embrace you. All that matters is that you line up as an ally in the drug war... Never mind that Osama bin Laden still operates the leading anti-American terror operation from his base in Afghanistan, from which, ... he launched two bloody attacks on American embassies in Africa in 1998.” (3)*

*“Then, in June, the American Embassy in Saudi Arabia initiated ... its new Visa Express program would allow any Saudi to obtain a visa to the United States—without actually appearing at the consulate in person. ... But Saudi Arabia was to be the only nation to enjoy the privileges of this new program, launched, in the most fertile breeding ground for terrorists in the world, for a simple reason: convenience.” (4)*

Of course, we now know that most of the terrorists involved in the 9/11 attacks were Saudi nationals. Since the War on Iraq is apparently an integral part of the current Administration’s “War on Terror”, it is only fitting that we briefly examine that issue. According to the Project for a New American Century, of which signatories include Vice-Pres. Dick Cheney and Secretary of Defense Donald Rumsfeld, explaining the need to take over Iraq:

*“...the need for a substantial American force presence in the Gulf transcends the issue of the regime of Saddam Hussein.” (5) Yet, the policy was so radical that even its authors realized that it would be impossible to implement ‘absent some catastrophic and catalyzing event—like a new Pearl Harbor.’” (5) Or ... like “9/11”. So, what does this all mean? A fairly recent Op-Ed piece in the New York Times offers a rather interesting scenario:*

*“In the original version of ‘The Manchurian Candidate,’ Senator John Ise-*

lin, whom Chinese agents are plotting to put in the White House, is a right-wing demagogue modeled on Senator Joseph McCarthy. As Roger Ebert wrote, the plan is to 'use anticommunist hysteria as a cover for a Communist takeover'." (6)

The Op-Ed continues: "The Arabian Candidate wouldn't openly help terrorists. Instead, he would serve their cause while pretending to be their enemy. After an attack, he would strike back at the terrorist base, ... but botch the follow-up, allowing the terrorist leaders to escape. ... Meanwhile, he would lead America into a war against a country that posed no imminent threat. He would insinuate, without saying anything literally false, that it was somehow responsible for the terrorist attack." (6)

How shall we conclude? Is Bush II the "Taliban Candidate," pretending to declare a War on Terrorism while actually supporting those same terrorists? The evidence shows close business and personal ties between the Bush family and the Saudis (including the Bin Ladens). Key Administration figures (for example our VP Dick Cheney) likewise have a compelling business interest in the Saudi Arabia. Saudi Arabia receives obviously preferential treatment from the current Administration (example: Secret Service protection of the Saudi Embassy, a privilege not extended to other embassies).

Saudi Arabia is the most prominent source of Islamic terrorists that, despite the too many promises made over the years, consistently shows no evidence of changing course. Some of Bush II's prominent Islamic supporters in his 2000 campaign turned out to have terrorist ties. Does this evidence suggest that Bush II is NOT the "Warrior on Terror" he holds himself to be, but instead, the "Taliban Candidate"? As Bush II's reelection bid draws near, we need to at least ask that and other difficult questions. However, I find I must leave it to the reader to draw his own conclusions.

Three:**

**COOKING SCHOOL**

**A**fter dining in Antoine's and Arnaud's, the foremost restaurants of French *haute cuisine* in New Orleans, Rita and I decided to sample the local Cajun and Creole cooking. Rather than going to a restaurant and selecting dishes from a menu, we decided to go to one of the several cooking schools in New Orleans to see how the dishes were prepared.

The demonstrations are given twice each day, before noon and before dinnertime. We knew that, without asking, that after watching the preparations we would be given the dishes to eat. We chose this particular time and place to attend because at this demonstration pralines were to be made, and Rita loves pralines. This was to be a meal and education all in one.

The New Orleans School of Cooking is located at 524 St. Louis Street behind the Louisiana General Store. The store sells herbs, spices, and seasonings used in Cajun and Creole cooking.

Following are the dishes that were prepared and their recipes. The recipes are as given to us with some minor modifications to accommodate the availability of ingredients in Florida and to incorporate some of the comments of the cooking master, Ann. Also I added a few comments of my own.

Ann was the demonstrator assisted by Marie. She is an outstanding raconteur and knowledgeable about all things food and cooking, which makes her an ideal person to demonstrate the cooking. As proof of that, all the dishes that she prepared were excellent.

## **GUMBO**

The name of this dish is derived from an African name for okra. The recipe given contains no okra, as Ann prefers it that way. Yet, how much more authentic could it be as it was presented by The New Orleans School of Cooking.

### **INGREDIENTS:**

**1 C. oil** (Lard or bacon drippings are traditional. Do not use butter or olive oil, butter will not make a roux and olive oil will impart a flavor not consistent with the dish. Vegetable oil or shortening may be used.)

**1 chicken**, cut up or boned (Use dark meat only. White meat cooks up too dry.)

**1½ lbs. Andouille Sausage** (Italian or Polish sausage will make an acceptable substitution. The flavors won't be exactly the same, but I think

that they will do.)

**1 C. flour**

**4 C. chopped onions**

**2 C. chopped celery**

**2 C. chopped green pepper**

**1 Tbsp. chopped garlic**

**8 C. chicken stock**

**2 C. chopped green onions**

### **Cooked Rice**

**Joe's Stuff** seasoning (In lieu of this packaged seasoning, which can be obtained from the Louisiana General Store, the following herbs and spices can be used; equal quantities of garlic powder, basil, marjoram, thyme, parsley, savory, mace, sage, onion powder, and black pepper plus chili pepper depending on how hot you want the dish to be. The recommended amount is one half as much as any of the other spices. If all these herbs and spices are not available, I think the omission of one or more would not be noticeable.)

**Filé** Also not used in Ann's demonstration. (A fine green powder of young, dried, ground sassafras leaves, used in gumbo for flavor and thickening. It may be placed on the table for individuals to add to their gumbo if they wish. 1/4 to 1/2 tsp. per serving is recommended.)

These quantities will provide 15 to 20 servings. Multiply or divide as necessary.

### **METHOD**

Brown chicken in oil over medium heat. Add sausage to pot and sauté with the chicken. Remove both from the pot.

Make a roux with equal parts of oil (must be free of food particles to avoid burning) and flour to desired color. The roux should be cooked to a dark brown-sugar color.

Add onions, celery, and green pepper. Add garlic to the mixture and stir continuously. After the vegetables reach the desired tenderness, return the chicken and sausage to the pot and cook with the vegetables, continuing to stir frequently. Gradually stir in liquid and bring to a boil. Reduce heat to simmer and cook for an hour or more. Season to taste with Joe's Stuff seasoning or herb and spice mixture noted above.

Approximately 10 minutes before serving, add green onions.

If you want to add some seafood, add it to the pot during the last five min-

utes.

Serve gumbo over rice or without rice, accompanied by French bread.

### **JAMBALAYA**

The origins of the name are obscure. Some derive the name from the French word for ham – *jambon*. That the dish is similar, in some respects, to the Spanish *paella* is obvious, but that doesn't necessarily indicate a connection. It may have an entirely separate origin.

### **INGREDIENTS:**

**1/4 C. oil** (See note above for oil)

**1 cooked chicken**, cut up or boned

**1-1/2 lbs. sausage** (See note above for sausage)

**2 heaping tsp. Joe's Stuff seasoning** (See note above for herbs and spices)

**4 C. chopped onions**

**2 C. chopped celery**

**2 C. chopped green pepper**

**1 Tbsp. chopped garlic**

**4 C. long grain rice**

**5 C. chicken stock**

**4 C. long gain rice**

**2 C. chopped tomatoes**

These quantities will provide 12 servings. Multiply or divide as necessary.

### **METHOD:**

Brown chicken in oil over medium to high heat. Add sausage to pot and sauté with the chicken. Remove both from pot. For brown Jambalaya, either add heaping Tbsp. brown sugar to hot oil and caramelize or make a roux (See note above for roux). For red Jambalaya, add paprika for color. Sauté onions, celery, green pepper, and garlic to the tenderness that you desire. Return chicken and sausage to the pot. Add liquid and Joe's Stuff and bring to a boil.

For red Jambalaya, add approximately 1/4-cup paprika. Add rice and return to boil. Cover and reduce heat to simmer. Cook for a total of 25 minutes. After 10 minutes of cooking, remove cover and quickly turn rice from top to bottom completely. Add green onions and chopped tomatoes if desired. Cook for a total of 25 minutes, turning completely after 10 minutes. If using an electric stove, reduce cooking time by 3-4 minutes.

For seafood Jambalaya, add cooked seafood when rice is turned.

## **BREAD PUDDING**

### **INGREDIENTS:**

- 1 10 oz. loaf stale French bread** crumbled (or 6-8 C. any type bread)
- 4 C. milk**
- 2 tsp. vanilla**
- 3 eggs**
- 8 Tbsp. butter, melted**
- 1 C. raisins**
- 1 C. coconut**
- 2 C. Sugar**
- 1 C. chopped Pecans**
- 1 tsp. cinnamon**
- 1 tsp. nutmeg**

### **METHOD:**

Combine all ingredients. The mixture should be very moist but not soupy. Pour into buttered 9" X 12" baking dish or larger. Place into a non-preheated oven. Bake at 350 degrees for approximately 1 hour and 15 minutes, until the top is golden brown. Serve warm with sauce.

This will serve 16 to 20 people

## **WHISKEY SAUCE**

### **INGREDIENTS:**

- 8 Tbsp. butter** (1 stick)
- 1 1/2 C. powdered Sugar**
- 2 egg yolks** (Put the egg whites in the bread pudding.)
- 1/2 C. bourbon** (to taste)

### **METHOD:**

Cream butter and sugar over medium heat until all butter is absorbed. Remove from heat and blend in egg yolks. Pour in bourbon gradually to your own taste, stirring constantly. Sauce will thicken as it cools. Serve warm over warm bread pudding.

**NOTE:** For a variety of sauces, just substitute your favorite fruit juice or liqueur to complement your bread pudding.

## **PRALINES**

Creole confections occupy a unique position in the United States; the most popular of these is the praline. Pralines derive their name from Marshal Luplesis-Praslin (1598-1695) and his butler's recipe for almonds coated in sugar, used as a digestive aid. When Louisiana was settled by French colonists, native pecans were substituted for almonds.

No lengths were spared by the Creoles to achieve perfection in candy making. Along with their vast collection of Creole recipes, cooks had their own secret method for making the best pralines, which they guarded carefully and handed down from generation to generation.

Today, pralines are as many and varied as they were in the very beginning.

### **INGREDIENTS:**

**1-1/2 C. sugar**

**6 Tbsp. butter** (3/4 stick)

**3/4 C. light brown sugar**, packed

**1/2 C. milk**

**1-1/2 C. pecans**, (roasted optional)

**1 Tsp. vanilla**

### **METHOD:**

Combine all ingredients and bring to a "softball stage" (238 — 240 degrees), stirring constantly. (When you place a spoonful into glass of water and it sticks to the side.) Softball stage is reached sometime after three minutes of a rolling boil. Remove from heat.

Stir until mixture thickens, becomes creamy and cloudy, and pecans stay suspended in mixture. Spoon out on buttered waxed paper, aluminum foil, or parchment paper. When using waxed paper, be sure to buffer with newspaper underneath, as the hot wax will transfer to whatever is beneath.

**NOTE:** To roast pecans, bake them on a sheet pan at 275 degrees for 20 to 25 minutes, until slightly browned and fragrant. Do not double the recipe. This recipe makes up to 50 pralines depending on the size. Pralines stay fresh for about three days.

***A View... From Somewhere Else***

**"SILENCE IS GOLDEN"**

**H**istory and Literature are full of examples of courageous people who speak up and speak out for the public interest. Since the beginning of civilization, such a person has been appreciated, admired, even held up as a model for emulation.

Regrettably, the exceptions to this noble tradition are found in 21<sup>st</sup> century America. It now seems that such a person is to be despised, silenced, and if possible, destroyed.

To the growing list of names that include Richard Clark, Paul O'Neill, Eric Shinseki, and Joseph Wilson, we can add a new entry: Teresa Chambers.

Until recently, Teresa Chambers was the Chief of the United States Park Police. This agency is comprised of over 600 members and is a component of the National Park Service within the Department of the Interior. The officers of the U.S. Park Police are responsible for law enforcement at the many monuments, memorials, and other public places in the nation's capital, such as the George Washington Parkway and Rock Creek Park (where the remains of Chandra Levy were eventually found). The U.S. Park Police also assure security at designated landmarks outside the metropolitan Washington area, including the Statue of Liberty in New York Harbor. Thus, the uniformed officers of the U.S. Park Police are literally the guardians of our treasured national symbols, which are obviously desirable targets for terrorists.

Chief Chambers was hired to fill this important position in February 2002, after a long and distinguished career as a law-enforcement officer, serving most recently as the Chief of Police for Durham, North Carolina.

For most of her tenure, Chief Chambers enjoyed good relations with her supervisor and upper management at the Department of the Interior. Endorsements of her performance were expressed in an informal fashion, such as congratulatory notes and e-mails following major events. Typical of someone in a high profile position, Chief Chambers had frequent contact with members of the media, a practice which was encouraged by her superiors. Additionally, she was encouraged to develop working relationships with members of the Congressional staff. Surprisingly, Chief Chambers never received any formal feedback on her job performance, such as periodic counseling sessions or annual appraisals.

Chief Chambers' troubles began in the Summer of 2003 when she began to raise serious concerns regarding funding and staffing at the U.S. Park Police. Due to the threat of terrorism, resources had been shifted to the more visible sites, reducing the police presence in other areas. This reallocation of resources had consequences. For example, the

increase in traffic accidents on the Baltimore-Washington Parkway showed a correlation with the reduction of U.S. Park Police enforcement there. Criminal activity increased at less prominent parks in the metropolitan Washington area. Homeland Security directives resulted in significant unfunded overtime requirements. Additionally, the organization's helicopter and radio communication system required upgrades.

While Chief Chambers attempted to effect some efficiencies in staffing, it was clear that the U.S. Park Police was an agency approaching a crisis, and in danger of a catastrophic failure.

Despite Chief Chambers' repeated warnings, her supervisors failed to allocate additional resources, nor did they reduce the mandates levied upon Chief Chambers and her agency. When her management finally did respond, it was by the hackneyed bureaucratic dodge of accusing Chief Chambers of failing to be "a team player."

Within a few months, Chief Chambers' primary staff assistant for fiscal matters was arbitrarily reassigned. Another critical financial position was left unfilled as a result of delaying tactics on the part of upper management. Budgetary decisions were made without Chief Chambers' input, using inaccurate and erroneous data. Several of Chief Chambers' trusted subordinates, who like her were new to the federal government, were subjected to harassing personnel actions.

In late 2003, Chief Chambers' predicament worsened dramatically based on three incidents:

- In early November, Chief Chambers contacted a staff member of the Interior Appropriations Committee, with whom she had previously established a working relationship. The subject was identifying a means to comply with another unfunded mandate.
- In late November, during a nationwide National Park Service conference call, Chief Chambers' supervisor publicly criticized her for the budgetary crisis. Chief Chambers was not a part of this meeting, but several subordinates and sympathetic persons were present. Upon learning of this dishonest and unprofessional conduct on the part of her supervisor from several sources, Chief Chambers filed a complaint on December 2.
- Also on December 2, *The Washington Post* published a story entitled "Park Police Duties Exceed Staffing." This story was based partially on an interview conducted with Chief Chambers in late November. Chief Chambers had honestly answered the re-

porter's questions regarding the fiscal and budgetary shortfalls impacting the U.S. Park Police.

On December 5, Chief Chambers was lured to her supervisor's office under the pretext of a meeting. Instead, she was placed on administrative leave and given notice that she would be recommended for termination. She was stripped of her badge and side arm by armed special agents of the National Park Service. To compound her humiliation, she was paraded in custody before her subordinates.

On December 12, Chief Chambers' supervisor offered to drop all charges based on several preconditions, including prior clearance of all communication with the media and Congress. Chief Chambers wisely and courageously declined this Faustian bargain. Only on December 18 did Chief Chambers actually see the spurious charges against her—improper communication with the media and congress, and insubordination. Additionally, the charges resurrected an incident from 2002, when a misunderstanding arose over the usage of a government vehicle. Without any guidance provided by the National Park Service, Chief Chambers had simply followed previous practices from her law enforcement career. The issue had been originally dismissed as a case of an overzealous inspector general.

After a period of over seven months paid leave, during which she contested her treatment by administrative and legal means, Chief Chambers was fired on July 9, 2004.

For refusing to lie and ignore serious problems, and for refusing to allow greater risk to the public, Teresa Chambers has been rewarded with professional and financial disaster.

We are fortunate that there are still people serving in government who are willing to tell us the truth, that all is not well, and that if we expect to be safe, we will need to sacrifice more. Considering the example made of Chief Chambers, however, one wonders how long this will be true.

**Lying Liars and  
the Fools Who  
Believe Them**

**T**he Democrat convention is finally over, and what did we get to see and learn from it?

Well, as best as I can tell, it came out as:

- (1) John Kerry served in Vietnam;

*"During Lt.(jg) Kerry's tour, he was under my command for two or three*

*specific operations, before his rapid exit. Trust, loyalty and judgment are the key, operative words... Kerry would be described as devious, self-absorbing, manipulative, disdain for authority, disruptive, but the most common phrase that you'd hear is 'requires constant supervision.'*" - Captain Charles Plumly, USN (retired)

*"I do not believe John Kerry is fit to be Commander-in-Chief of the armed forces of the United States. This is not a political issue. It is a matter of his judgment, truthfulness, reliability, loyalty and trust -- all absolute tenets of command."* - Rear Admiral Roy Hoffman, USN (retired)

*"I know John Kerry is lying about his first Purple Heart because I treated him for that injury."* - Dr. Louis Letson (Lieutenant, Medical Officer, Cam Ranh Bay)

*"John Kerry lied to get his bronze star. I know, I was there, I saw what happened."* - Gunner's Mate 2nd Class Van O'Dell

These are just a few of the quotes from the men who served with John Kerry, alongside John Kerry, and were his superiors. They were there. So where are the investigations? Where are the smug nightly condemnations from Dan Rather, Keith Olbermann, et al?

The answer might be found in a quote from Evan Thomas, the Assistant Managing Editor of *Newsweek*, a magazine nobody on this planet would ever refer to as conservative.

On *Inside Washington*, a weekend discussion show taped at and run by the Gannett-owned CBS affiliate in Washington, DC, WUSA-TV, and carried by many PBS stations across the country, Thomas pointed out the boost to the Kerry/Edwards ticket provided by the press corps:

*"There's one other base here: the media. Let's talk a little media bias here. The media, I think, wants Kerry to win. And I think they're going to portray Kerry and Edwards -- I'm talking about the establishment media, not Fox, but -- they're going to portray Kerry and Edwards as being young and dynamic and optimistic and all, there's going to be this glow about them that some, is going to be worth, collectively, the two of them, that's going to be worth maybe 15 points."*

One of the central themes, in fact the most-often repeated attack on President Bush is that "he lied about the WMDs, he lied about Saddam trying to get uranium from Niger".

*"The British government has learned that Saddam Hussein recently sought significant quantities of uranium from Africa."* This quote from the President's 2003 State of the Union Address has been more often misquoted by dropping the first six words. However, the original is a true statement, one that British intelligence stands by to this day. And the factuality of the statement has also been enhanced due to the utter demolition of the credibility of Joe Wilson, the "expert" who spent 8 days in a hotel room in Niger, and, as has now been exposed, never talked to a single official of that

country competent to speak on the issue.

As to the left's claim that the President lied about there being any ties between Hussein's Iraq and Al-Qaeda, even the left-leaning 9/11 Commission had this to say:

***"Were there contacts between al-Qaeda and Iraq? Yes. Some of them are shadowy, but there's no question they were there."*** (Chairman Tom Kean)

***"The Vice President is saying, I think, that there were connections between Al-Qaeda and Saddam Hussein's government. We don't disagree with that."*** (Vice Chairman Lee Hamilton)

But what did the media have to say?

ABC's Peter Jennings insisted the commission had ***"unequivocally" contradicted what the administration had maintained***". CBS Evening News John Roberts asserted that the commission had ***"directly contradicted one of President Bush's justifications for going to war against Iraq"***. And on NBC Nightly News Tom Brokaw characterized the commission as ***"sharply at odds with what leading members of the administration continue to claim."***
