Part Nine: NÜRNBERG (Continued):

**I am not aware** if any good resulted as a consequence of this communication but it was heartening to see our thoughts recorded in this manner. For a while we felt an expectation that a march of this nature might become a reality.

Life in this camp never reached the level of being humdrum. We were happy to see that some of the sergeants that were shot down with us were moved into this camp. It appeared that many of the POW camps in Germany were converging on Nurnburg as a central point. The Russians were moving in from the east and the Allies from the north and west. These reunions lent a feeling of excitement that the end of the war was fast approaching. A pilot, I believe his name was Brown, wandered into our barracks one morning. He was an acquaintance of Ted Goller. They had gone through one phase of pilot training together. Brown had been shot down and managed to evade capture. He was under the control of the 'French underground' awaiting the necessary connections to be able to return to England. He was enjoying a rather pleasant life in Paris as a guest of the French while waiting. As the American Army drew closer to Paris, the Germans were packing and making preparations to leave. The day before they abandoned Paris, Brown was picked up by the German Security Police. Brown was in civilian clothes and had no evidence of being an American flyer so he was hustled off to Buchenwald, a concentration camp near Weimar in central Germany. He was held there for a number of months until they could establish his true identity.

When Brown was moved to our Stalag Luft he had been in Buchenwald for a couple of months. That was long enough to produce the look of starvation that was typical of many long term prisoners held in concentration camps. From what he described we assumed that he was subjected to all the discomforts we were suffering in Nürnberg. Cold, hunger, squalid filthy barracks and some abuse from the guards were his daily routine. He described the simple pleasure he enjoyed when the sun shone. He could lie on a large rock and enjoy the warmth of the sun. He was happy to be in this camp with us. He did not mention any brutal treatment or discrimination against any particular group. He felt that all were treated impartially.

The German news broadcasts into our compound kept us informed of the progress the Allies were making. Hitler's speeches to

the people carried the message that they must never give up. New weapons were in the mill and that soon Germany will turn the tide and be victorious. He spoke of one secret weapon that in retrospect we believe that must have been the development of an atomic bomb.

It could not have been the V-2 bombs that he was promising because these were already in use. Their effectiveness was minimal. In the progress of the war the destruction they wrought made no appreciable difference. They knocked out a few buildings in England but compared to the destruction the British and American bombers caused German industry, the V-2s were not much more than a nuisance.

It would have been a different situation if he had been able to come up with an atomic bomb and could deliver it to knock out London completely as we did to Hiroshima and Nagasaki later in the war. Hitler didn't mention atomic warfare. At that time we were not cognizant of the concept. He spoke to his people in the strongest terms that very soon this nightmare would be over and Germany would dictate the terms of the peace treaty.

We felt that many Germans were tired of the war and would welcome anything that would bring it to an end. In 1944 while we were still in Sagan an attempt on the life of Hitler failed. Some of his most trusted officers plotted to assassinate him by placing a bomb in the room where he was to meet with his advisors. It failed and thus failed to end the war at that time. I think that more than one of the plotters faced the firing squad.

*\*Hitler had a charismatic personality of overpowering forcefulness. He knew how to appeal to people's base instincts and made use of their fears and insecurities. He could do that, however, only because they were willing to be led, even though his program was one of hatred and violence. His impact was wholly destructive, and nothing of what he instituted and built survived.\**

I guess in a way he was a madman but he was a pretty well organized guy with enough skills to keep control of his armed forces and for the most part was able to control the civilian population.

## Shall We Dance?

**T**his year's National SCRABBLE® Championship was held in nearby Orlando, Florida. One can access information about the players from the National SCRABBLE® Association's website. Of an estimated 582 participants, approximately 348 listed hobbies in their brief biographies; of these, about six made reference to dancing. I also remember a local player whose passion for the SCRABBLE® cross-word game was seemingly supplanted by an enthusiasm for dancing. It is with her in mind that I compose this month's column.

Some nouns in *The Official SCRABBLE® Players Dictionary, Fourth Edition* (OSPD4) are defined as "a [or an] \_\_\_\_\_ dance" where the blank is filled with a geographic proper adjective: BOLERO, JOTA, and ZAPATEO (Spanish); CAPOEIRA, LAMBADA, and MAXIXE (Brazilian); CARIOCA (South American); CZARDAS (Hungarian); FADING (Irish); GAVOT and LANCIERS (French); HABANERA (Cuban); HORA (Israeli); HULA (Hawaiian); LEGONG (Balinese); and MAZURKA (Polish). Sometimes an additional modifier is used: BOURREE (old French), FANDANGO (lively Spanish), KAZACHOK (Russian folk), KOLO (European folk), LANDLER (slow Austrian), MORRIS (English folk), SARABAND (stately Spanish), and SARDANA (Spanish folk). There are similar definitions with no reference to the location of a dance's origin or popularity: BEGUINE, GALLIARD, GIGUE, JUBA, LINDY, REDOWA, and RIGADOON (lively); CHACONNE (ancient); COOCH (sinuous); COTILLON (ballroom); COURANTE (old, lively); GALOPADE (lively round); GERMAN (elaborate); HOEDOWN (square); MERENGUE (ballroom); MINUET and PAVAN (slow, stately); and NONDANCE (unrhythmic). PROM, being defined as "a formal dance," also fits this pattern, but it refers to a gathering at which dancing is performed rather than the act of dancing itself. COTILLON (an alternate spelling of COTILLION, which at nine letters is too long to be defined in OSPD4) and HOEDOWN can also refer to a gathering, as does SHINDIG, "an elaborate dance or party," which *almost* fits the pattern. Attention should also be paid to CANCAN, "a dance marked by high kicking."

In some cases, a dance is defined parenthetically within another definition. The definition given for JIGGISH is "suitable for a jig (a lively dance)." FOXTROT is defined as "to dance the fox trot (a dance for couples)" and CONGA is defined as "to perform a conga (Latin

**I** spent about forty years as an independent voter with Democratic tendencies. I liked Reagan, didn't mind Bush Sr., and had kind of a root for the underdog attitude towards Gerald Ford. But more often, I leaned towards the Democrats.

**A**s you read this, I'm sure this topic will be classified as Old News. Yet, mere days before I wrote this column, Republican presidential nominee John McCain had just announced his running mate, Alaska Governor Sarah Palin. It seems Governor Palin was chosen in order to win the votes of the Christian Right.

Well, no sooner than it took to commit the Palin name to our memory drives, news broke that her 17-year-old unmarried daughter, Bristol was five months pregnant. McCain, commenting on this news, stated he was aware of the pregnancy, but declared that the issue is a private family matter. Democratic presidential candidate Barack Obama stated that the issue of Bristol's pregnancy was "off limits" to his campaign.

While I understand – and sympathize with – McCain and admire Obama for resisting the temptation to take the low road, I must say that I only partially agree with them. I do strongly believe one's family life is one's private business. Yet, I believe there is an object lesson here.

One obvious point is that pushing "abstinence" as effective contraception does not work. Moreover, I'm sure Sarah Palin, who has evidently bought into the "Judeo-Christian ethic" would not want to see her daughter suffering the Old Testament-prescribed punishment of being stoned to death for fornication. Admittedly, neither would I.

More importantly, since we're on the subject of "values", one concept that comes to mind is the Golden Rule, "*Do unto others as you would have them do unto you.*" Since, understandably, the Palins wish to have their privacy respected, perhaps all American families should be accorded the same privilege – even when our activities do not square with anyone's notion of "values".

Finally, one other maxim comes to mind: "*People who live in glass houses should not throw stones.*"

**C**ampaign 2008 is now on the home stretch. As I write this, much public attention seems to be focused on the “Palin Effect”. Surely, one realizes there is much more to this year’s election than Sarah Palin. Of course, there is the actual *presidential* election – but most of us already knew that. Yet, is there not still more? Certainly, I would say so.

One such campaign that needs far more attention than is afforded is the race for U. S. House of Representatives, specifically the seat for Florida’s District 15 (which covers much of the geographic area of *The SCAM*). This seat is currently held by Republican Dave Weldon, who is finishing his seventh term. Although there are no term limits, Rep. Weldon opted not to seek an eighth term.

During his tenure, Dave Weldon has consistently proven that his views and policies are virtual duplicates of those of our current President Bush. In view of the fact Weldon is not seeking reelection, he has endorsed *State Senator Bill Posey* as his successor.

Bill Posey has been in the state legislature since 1994. His views have not been much different from Weldon’s or Bush’s. His list of supporters is a virtual *Who’s Who* from the Bush cult: *Rep. Tom Feeney, Sen. Mike Haridopolos, Gov. Mike Huckabee*, just to name a few. Some organizations that back Posey: *Associated Industries of Florida, Business Industry Political Action Committee, Florida Right to Life, Space Coast Association of Realtors*. His top campaign contributors have consistently been financial institutions and the insurance industry. We can see what kind of effect these organizations and their political employees (our elected officials) have had on us as Floridians – one needs only to look back over the last few years (*e.g., foreclosures, doubling of homeowners’ premiums*).

The Democrat in the race is *Dr. Steven Blythe*. In his campaign, he has pledged not to take corporate or PAC contributions. More importantly, he realizes that for most of us, the past few years have not been good ones. Even better, he is a man of ideas. These are just a few examples of what he wants to accomplish as our Representative:

1. Launch a massive program to repair our infrastructure, including old bridges and leaky school roofs.
2. Have several large block grants to help build light-rail systems in some of our most heavily-traveled corridors. This would create thousands of jobs, preserve our envi-

- ronment, and conserve our energy resources.
3. Create incentives and tax breaks to encourage a massive transition to solar and alternative energy wherever practical.
  4. Guarantee no American will have to go without health-care.

In my opinion, we need a House of Representatives filled with people like Steve Blythe, people who will once again get this country moving in a positive direction that will benefit *all* its citizens, not just the wealthy and powerful few. While the outcome of this year's presidential election is critical for this country, the race for Florida's Congressional District 15 is no less so. We hear much in the ever-present campaign ads about "change"; now is the time for us to vote for *real* change.

American dance).” In other definitions, it appears that a specific dance is referred to implicitly. FRUG is defined as “to perform a type of vigorous dance”; MAMBO, RUMBA, and WALTZ are defined as “to perform a ballroom dance”; POLKA is defined as “to perform a lively dance”; SAMBA is defined as “to perform a Brazilian dance”; and TANGO is defined as “to perform a Latin-American dance.”

Other verbs with “dance” in the definition are GAVOTTE (to dance a gavot), BOOGIE (to dance to rock music), CHASSE (to perform a dance movement), DISCO (to dance at a discotheque), GLISSADE (to perform a gliding dance step), and HOOFF (to dance). DANCE itself is defined as “to move rhythmically to music.”

But what kind of music? OSPD4 seems to offer little choice. BANDA is defined as “a style of Mexican dance music,” CONJUNTO is defined as “a style of dance music along the Mexican border,” RAGTIME is defined as “a style of American dance music,” and ZOUK is defined as “a dance music of the French West Indies.” Perhaps someone with sharper eyes or more patience can find other appropriate entries.

Of course, it is not necessary to know the definition of a word in order to play it during a game. It would be more to the point to become familiar with words that are likely to come up on a player’s rack. A fresh bag of tiles contains twelve Es, nine As, nine Is, eight Os, six Ns, six Rs, six Ts, four Ds, four Ls, four Ss, four Us, and three Gs, as well as two blanks; there are only one or two of each remaining letter. Therefore, one should be prepared to play DANSEUR (a male ballet dancer), LINDIES (plural of LINDY), or TANGOED (past tense of TANGO) when the opportunity arises; a player scores a fifty-point bonus for using all seven tiles. If DANSEUR will not fit, it may be helpful to know that ASUNDER can be formed from the same letters.

Would anyone purchase a game based on the slogan “Let your fingers do the dancing”? Probably not. Well, I tried.

**T**he lengthy quote in this month's column is from last month's column by RVC8 John Recht, who is the head of the Governance Project. He is asking for input from you the member. Please read what he has to say and contact him if you have ideas and feedback for and about the Governance Project.

“Last month I spoke about the Governance Project that the American Mensa Committee (AMC) has undertaken with the help of Tecker Consultants. The next major step in this process will take place in November at the AMC’s annual planning meeting. At that time the AMC will have the chance to make substantial, ongoing changes in the way it operates, beginning with the development of a solid strategic plan. This plan will help better define authority and responsibility of the AMC, officers, committees and staff, as well as set tangible goals and the measurements for success.

Critical to the success of this plan will be for the AMC to choose goals that will be important to the ongoing growth and development of American Mensa. As the AMC spends proportionately more of its time making decisions that are more strategic in nature, it will correspondingly find less on its plate that pertains to the development of rules and procedures. Increasingly, authority will be delegated to staff and committees to follow up with what needs to be done in the organization.

What are the goals that will be important to American Mensa? Between now and November the AMC members will be discussing their ideas about what the goals should be and how the current list of short-term and long-term goals should be revised. What would help us tremendously at this time would be to have interested members weigh in with their ideas and feedback about the Governance Project and the strategic planning process now underway, as well as specific goals that they believe would be of benefit to the society.
