**I**n a recent article in the *Wall Street Journal* by Raymond Sokalov, he describes the latest trend in dining in Manhattan. Long the citadel of upscale, fusion, and exotic cookery, some restaurants have reverted to homey, comfort food, particularly macaroni and cheese.

This staple of home cooking (*that's a stretch on the word "cooking" when prepared out of a box*) pleased the kids and saved money, a box can cost as little as 33 cents for a generic brand in some dollar stores to feed four. It can also be made from scratch, the basic recipe includes pasta, usually elbow macaroni but not limited to that, American cheese (Velveeta is a standard), butter, and milk. Cook the macaroni, melt the mixture of the cheese, milk, and butter and pour over cooked pasta. In these days of austerity, macaroni and cheese fits right in.

What can an upscale restaurant do to it to make it interesting to their clientele and to charge enough to make a profit? They do things like using other cheeses than the ubiquitous American, such as Hickory smoked cheddar, blue, camembert, and Swiss, and add other things to the basic cheese. Things that can be added are bread crumbs and toppings such as mushrooms, masala to make an Indian version, pizza sauce and spices to make it Italian. Other macaroni shapes rather than the ubiquitous elbow macaroni can and are used.

Although quintessentially American, macaroni and cheese is not exclusively American. In England the dish is called "macaroni cheese" and in Caribbean English, macaroni pie. The Swiss version is called *Älplermaaronen*. *Pasta al burro*, which means "pasta with butter", is the classic, least expensive Italian pasta dish, is always served with a generous serving of grated Parmesan cheese on top, making it a macaroni and cheese. A more upscale version of Italian macaroni and cheese is pasta with Alfredo sauce.

In the U.S. variations on the basic dish are common. Additional ingredients are used such as vegetables (broccoli, cauliflower), meats (sausage, hamburger), herbs, and spices. The variations are unlimited.

There is no need to be embarrassed about serving this most inexpensive dish. Just add or change a few ingredients and give it a foreign name and you will be counted among the gourmet cooks.

Perhaps a mix of the sort of items on a New York Times op-ed page, minus, hopefully, partisan politics. On the other hand, "Political theory" - whatever that is - might go reasonably well.

This is currently envisioned as an after dinner get together with light refreshments and probably wine. Those who attend will be solicited for opinions and how to do it better the next time, and with any luck, this may evolve into a regular, enriching, and useful event.

On re-reading the above, I see the spector of pretentiousness hovering overhead. Too bad. That's the price of hosting a Mensa event without games.

But we do have a "back room"... And if, by any chance, this announcement is greeted with great enthusiasm, we might attempt to get started in August.

**I**n many different contexts, I have often heard it said that truth is stranger than fiction. One recent instance is a pending case, *Susan B. Anthony List v. Driehaus*. According to the June 17 issue of the *New York Times*<sup>(1)</sup>, the United States Supreme Court is permitting the legal challenge presented in that case. Essentially, the case is about two political advocacy organizations, Susan B. Anthony List and Coalition to Oppose Additional Spending and Taxes, who are challenging the constitutionality of an Ohio law that criminalizes making knowingly or recklessly false statements about candidates to either help elect or defeat the candidate for a public office.

I first learned of this case when, in March, I came across an amicus curiae brief<sup>(2)</sup> satirist P. J. O'Rourke submitted in support of the constitutional challenge. In that brief, O'Rourke opines: *"This Court has repeatedly held that political speech, including and especially speech about politicians, merits the highest level of protection. Indeed quite recently this Court held that the First Amendment protects outright lies with as much force as the truth (Citations omitted)."*

There you have it: Assuming P. J. O'Rourke is correct, the First Amendment, along with its other rights, also declares that we have the right to lie. Can that really be? Let's take a look at the case. At issue is an Ohio law enacted back in 1995, Chapter 3517.21<sup>(3)</sup>, which reads in part: *"No person ... shall knowingly and with intent to affect the outcome of such campaign do any of the following:*

*(9) Make a false statement concerning the voting record of a candidate or public official;*

*(10) Post, publish, circulate, distribute, or otherwise disseminate a false statement concerning a candidate, either knowing the same to be false or with reckless disregard of whether it was false or not, if the statement is designed to promote the election, nomination, or defeat of the candidate."*

This case itself began in 2010, when in opposition to Congressman Steve Driehaus's reelection bid, the Susan B. Anthony List (SBA List), an anti-abortion group advertised that, by voting for the Affordable Care Act (known as "Obamacare"), Driehaus had voted in favor of "taxpayer supported abortions". In response, Driehaus filed a complaint with the State of Ohio alleging that the SBA List violated Chapter 3517.21 by lying about his voting record.

Driehaus ultimately lost his reelection bid and subsequently withdrew the complaint. The SBA List, on the other hand, filed a challenge to the Ohio

**I thought I would try** to find a mathematician born on the 4<sup>th</sup> of July for this month. Not only did I find one, but he is a writer as well. Not only that, I have read most of his books that he has written for the public. In addition, not only that: He is a professional mathematician I have talked with on one occasion.

John Allen Paulos was born July 4, 1945 in Denver, Colorado. He is a professor of mathematics at Temple University in Philadelphia. He gained his BS (University of Wisconsin) and MS (University of Washington) and PhD (University of Wisconsin) in mathematics and did a stint in the Peace Corps before entering the field of math. He has gained recognition as a speaker and a writer on the importance of mathematical ‘ill’- literacy (a term called ‘innumeracy ‘by many that he helped popularize) concerning the layperson misconception about numbers, probability, and logic.

His academic work has been primarily in mathematical logic and probability theory. However, he is most noted for his books for the public. *Innumeracy: Mathematical Illiteracy and its Consequences*, was actually a bestseller and *A Mathematician Reads the Newspaper* extended the knowledge of the public when reading newspaper articles ( much in a humorous vein, but also explaining important mathematical concepts in determining their veracity and confusion in applying math.). Some other books of his that I have also read are *Mathematics and Humor*, *I Think therefore I Laugh*, *a Mathematician Plays the Stock Market*, and arguments for and against a deity’s existence in his book *Irreligion*. He uses quirky anecdotes, facts, scenarios, personal experiences, and humorous cartoons and jokes to encourage readers to look at their world in a more quantitative fashion.

Paulos has appeared on radio and television shows, including the BBC adaptation of *A Mathematician Reads the Newspaper*, and has appeared on what was the *Lehrer News Hour*. He was also a guest on *20/20*, *Larry King*, and *David Letterman*. He has received the American Association for the Advancement of Science Award for promoting the public understanding of science and technology (2003). As well as received the University Creativity Award at Temple University (2002). His article, “Counting on Dyscalculia”, appeared in *Discover* magazine in 1994 and won a Folio Award for that year.

After I had read some of his books and provided a review on *Amazon*, I talked with Paulos. He has a very dry sense of humor and comes across as a very respectful and thoughtful person. I mentioned to him once that I thought that when I retired some day, I might want to teach a math class part-time to help people understand mathematics in their daily lives. He said that was a

worthy ambition, but not to try and get my hopes up too much. In his many years of teaching, he found some students just seem to take to liking math naturally and could see its applications. He found it at times frustrating with trying to motivate some students, who seemed to think they could never understand mathematics at all in life and did not feel it was that important to them. However, he said that if I did pursue that activity; to never give up hope in trying to help others better understand the use of mathematics in their lives.

If you get the chance to read one of his books, then do so. They are informative and entertaining, as well as being a quick read. Well 'red', 'white'- up your alley, and 'blue-ti-ful' humor.

law, essentially stating that criminal sanctions against making false statements against a candidate for public office violates its free speech rights under the First Amendment to the U. S. Constitution.

As the SBA List challenge worked its way through the courts, each court in turn had rejected the challenge because the Driehaus complaint had been withdrawn. The challenge then went to the U. S. Supreme Court, who, on June 16, decided that the SBA List did have standing to challenge to the Ohio law<sup>(4)</sup>.

In short, the SBA List is now free to pursue its litigation. I, for one, am looking forward to it. The question brought forward by the SBA List needs to be definitively answered.

Finally, what are the possible answers? Certainly, the SBA List, with the support of its allies, will pursue the case. It is my guess that the case will eventually wind up again before the Supreme Court. Once there, the Supreme Court could rule, generally speaking, in three ways:

1. The Court could reject the challenge outright and uphold the Ohio law, in effect declaring that lying is not protected speech under the First Amendment.
2. The Court could uphold the challenge and rule the Ohio law unconstitutional on its face, thus declaring that lying (in the context of political speech) is protected speech under the First Amendment.
3. The Court could rule the Ohio law to be unconstitutional because it finds technical defects with that law that it rules is chilling to free speech, effectively sidestepping the question of whether lying is protected free speech.

I plan to follow this case until it reaches its conclusion. It will be interesting to learn the outcome and how (or if) the Supreme Court rules on whether lying is free speech. However, if I were to guess the outcome, I believe the final decision will be some incarnation of Option 3, leaving the underlying question unanswered. Yet, this may not be all bad.

I fully support the Ohio law banning lying to influence elections. I believe other states (including ours) should have similar laws on the books. If the Supreme Court rules as I believe it will, the ruling can serve as an instruction manual of sorts to guide our lawmakers in crafting an effective “anti-lying” statute that would survive a Constitutional challenge.

"MaRGaritaville" was the largest gathering they've thrown in years, with members attending from all over the country (thanks to terrific of support from members of the American Mensa FaceBook community) to a new hotel venue in Oldsmar. Kudos to all involved in putting this event together, including Art Schwartz, Sylvia Zadorozny, Melissa Stephens and Jack Brawner, and all other volunteers who helped to make this a success!

Also, I'd like to continue my congratulations to the Central Florida Mensa public relations team, led by Public Relations Officer David Fleming and Membership Officer Debbie Freeland. Becoming a proctor requires that you have a four-year degree (required by the company from whom we license the tests, not by Mensa), observing up to two proctored tests being administered, and being observed administering up to two proctored tests. Other news over the past couple of months: I worked with Gainesville Area Mensa to appoint a new Executive Committee, after a series of events left them without any leadership. Thanks to Mark Kelly, Mike Perry, Pat Bartlett and Kathleen Stipek for stepping up until their elections in November, and for moving forward with updating their bylaws.
