**W**hen thinking about Colonial Era food, Brunswick Stew always comes to mind. It is considered to be typically and originally American although there some intelligence of it being initially German.

While contemporary recipes have chicken as the meat ingredient, older recipes call for rabbit, hare, squirrel, and/or possum. The use of these meats in Colonial times is understandable, they were small, (relatively) easy to catch, and dress. Something the housewife or children could do without resorting to the man of the house and his gun to provide larger game such as deer.

The recipes are extremely variable, dependent on what was available at the time of the making. The following is a recipe from *The Williamsburg Art of Cookery* in a contemporary typeface.

*Cut up two squirrels and put in a large pan with three quarts of water, one sliced onion, one half pound of lean ham cut in small pieces and simmer gently for two hours. Add three pints of tomatoes, one pint of lima beans, four large Irish potatoes diced, one pint grated corn, one tablespoon salt, one fourth teaspoon pepper, a small pod of red pepper. Cover and simmer gently for one more hour stirring frequently to prevent scorching. Add three ounces of butter and serve hot.*

For a more modern recipe, many cookbooks and the web has many.

**I**n the 2015 Mensa national elections next April, there will be no fewer than thirteen (13) different bylaws amendments for members to evaluate and vote on. There will also be multiple candidates for several of the national offices. This level of interest and participation on the national level has not been seen for quite some time – and it has gotten my attention.

Having done a fair amount of research and then reviewed all 13 of the proposed bylaws amendments, I find myself unable to support anything substantive put forward by the current American Mensa Committee (AMC). Nor will I be supporting any of the incumbents on the AMC ExComm. Discussions continue on Facebook, Yahoo Groups and the Mensa Online Community, as well as in person across the country. I invite you to join the conversation.

A significant issue is the pattern of continuing dues increases, outpacing the inflation rate. The current AMC has approved these dues hikes but, until now, they have resisted repeated attempts by the current Treasurer, Nick Sanford – now running for Chairman – to institute automatic annual dues increases. We will have other choices for both Treasurer and Chairman this year; it behooves us to consider how our dues money is spent and whether we are getting additional value for higher annual dues.

Several members have pointed to the ongoing expansion of the National Office without an accompanying growth in membership numbers. Others have called for a different approach to the budget process and an accompanying rollback of dues; to achieve this, we would need quite a different AMC and ExComm.

A careful reading of the proposed bylaws amendments, along with a review of this year's AMC meetings agendas and minutes, reveals quite a lot about the thinking of the incumbents who participated in the creation of AMC-approved amendments and who would be operating under the revised rules if those amendments were to pass.

A recent RVC column by Julia Ashley (*Region 3*) and the subsequent response from Dayton Area Mensa's Ombudsman Pat Reising elucidate some of the issues relative to the position and role of the National Ombudsman. The links below lead to an exchange regarding two of the proposed bylaws amendments: #1, Replacement of the text of Bylaws of American Mensa in entirety, and #12, Restore and Protect Powers of the National Ombudsman. An associated proposal, #11, Duties and Responsibilities of the National Ombudsman, is referred to indirectly in the writings and should be considered as part of the

Congratulations also to Mensa of Jacksonville, who was one of four Local Groups chosen as a winner in the Plus ONE promotion for their testing activities in 2014. They were awarded an additional \$500 for their achievement.

There are also signs of recovery in Miami Mensa, who have reestablished their monthly Speaker meetings and have had experienced increased attendance over the past few months. Again, thanks to LocSec Vincent Chen, Program Chairman Barry White, and all who are striving to make their group a success.

Central Florida Mensa held their very successful "Sun 'n' Games" Regional Gathering in January, and is gearing up to host their second Mensa booth at Orlando's MegaCon in April. Tampa Bay Mensa hosted an afternoon cruise for their members out of Clearwater in January, and is preparing the "Margarita Bay" Regional Gathering for Memorial Day weekend.
