## RVC10—Thomas G. Thomas

On July 28, 2022, a special session of the American Mensa Committee (AMC) was held via teleconference to review a Hearings Committee report recommending the expulsion of a member who had engaged in persistent harassment and intimidation of another member during authorized Mensa activities. The AMC concurred with the recommendation, considering the situation serious enough to authorize only the 10<sup>th</sup> expulsion from American Mensa over the past quarter century.

In order to preserve the privacy of the individuals involved, the discussion was held in closed session, so there will be no recording or detailed minutes available, although the charges, recommendation and decision can be found in the mini-minutes posted at <https://www.us.mensa.org/lead/amc/meeting-reports/> under the dropdown "2022-07-28 — Teleconference".

I was asked why this special session was necessary so soon after the previous AMC meeting just three weeks earlier. Unfortunately, the Hearings Committee did not provide the AMC with their report and recommendation until the day after the quarterly meeting, but the seriousness and immediacy of the charges required that the matter be addressed as quickly as possible, and our Bylaws required a minimum 14-day notice to the membership that a special meeting would be convened.

One of the pillars of Mensa held in its Constitution is that we provide a stimulating intellectual and social environment for our

members. Such an environment cannot be maintained when personal boundaries are deliberately, persistently, and dangerously crossed, and such behavior must be dealt with decisively if the society is to continue. Such actions are not taken lightly, but when threats to our members are brought to our attention they cannot be ignored.

The next meeting of the AMC will be held at the American Mensa headquarters in Hurst, TX on September 17, 2022.

## Let's Talk VPN

VPN stands for Virtual Private Network. Using VPN creates an encrypted connection between your device and the server providing the VPN. That is all it does. It will not create encrypted connections to every site you visit. If you are using a purchased VPN service for home use and think that you are protected from things like trojans, viruses, and ransomware, you would be mistaken. VPN affords you little to no protection unless the network you are connecting to is private. For my VPN connection to work, I authenticate to a company server which allows me to reach company resources I would otherwise have to be on location for. At the same time, I am able to go to youtube or google. Are they secure? Nope. If I go to a site and download a file with a trojan, it will still infect my system and, potentially, other company assets.

Bottom line: Virtual Private Networks are not private and they are not secure.

Why do so many people use them for their personal Internet surfing? Because they *think* it is more secure or they think their IP address is truly hidden. They believed the hype and don't understand all the nuances of how the Internet works. If you want to be secure on the Internet, follow safe browsing practices and secure your home network and connected devices.
