**W**ith all its power to write taxes, it is surprising that our government resorts to deceptions to increase our tax liabilities when they could just raise our taxes. Here are two.

**1. Withholding Tax**

This year, in addition to the usual scams that cheat the taxpayer of part of his income, we now have the increased possibility of scammers accessing your tax returns and claiming your tax refunds. According to the Wall Street Journal, there were \$5.8 billion estimated fraudulent refunds the IRS paid in 2013. This year it will be much more. If the IRS cannot recover those fraudulent payouts, and it is unlikely that they will be able to recover much, if not, all of those funds, it is the honest taxpayer that must cover those losses.

Taxes must be withheld from the wages of all employees with some exceptions. The amount withheld is determined by a formula or chart promulgated by the IRS. It usually exceeds the taxable amount on the wage earners income resulting in refunds that are now subject to the tax fraud scammers. This is deliberate cheating by our IRS. The excess tax that one pays in withholding is your money, not the IRS's. Yet they will not pay it to you unless you ask for it on you income tax form 1040. It is a no interest loan to the IRS that you can get repaid only by applying for it if it has not already been given to some tax fraud scammer. You are not paid interest on the overpayment. Yet, if you underpay your withholding tax you are subject to interest and other penalties. The best way to avoid being cheated by the IRS or exposing your self to scammers is to adjust your withholding so that you have no refund coming to you at the end of the tax year.

There are several legal ways to do that, none are easy. Check the web.

This form of cheating by the government generally applies to only the middle class of taxpayers. Those that do not have wages or other income subject to withholding can usually avoid this gambit, which means the very wealthy and the very poorest persons who have no wages.

## 2. Capital Gains

Another form of cheating by our government is capital gains. This doesn't affect most of us taxpayers who, like me, have no capital gains to declare. However, it is so insidious, that it must be addressed.

If you purchase an investment, say for \$10,000 and years later sell it for \$15,000, according to the IRS you have a capital gain of \$5,000 and are taxed on that amount. When you bought that investment, you could have, instead, spent that money on wine, women, and song. Years later, when you sell that investment for \$15,000, you find that, because of inflation, the \$15,000 buys only the same amount of wine, women, and song that the \$10,000 would have bought when you purchased that investment. Inflation has eaten into that investment. If inflation was exactly equal to your increase of investment, you would still be liable for a \$5,000 capital gain. Of course, that is illogical. There has been no capital gain. You can purchase no more now with the \$15,000 than you could have bought with the \$10,000 then. What has happened isn't inflation, but devaluation of the dollar. Why should you pay a tax on a decrease in the dollar's value when that is solely and arbitrarily mandated by government policy?

This election offers us an unusual opportunity to examine who we think we are, where we want to be and who we shall choose to lead us toward our goals. Happily, these days it is relatively easy for members to get a sense of what's been going on. Just click on a few links, scroll down to the referenced articles and – voila – enlightenment!

– **Is Mensa a club or is Mensa a business?**” (1)

### **Fix Mensa's Finances**

One reason for the incessant push to increase dues is the Equity Restoration program necessitated by the Inpharmatica trademark lawsuit initiated by the AMC in 2009. Few members are aware of this huge deficit; AMC actions taken at the March 2014 meeting could cause this important element of Mensa's internal finances to slip quietly off the radar. (2)(4)

We can – and must – do better when preparing and administering our budgets. (2)(3)(7)

### **Fix the American Mensa Committee (AMC)**

“[Actions were] taken last year by the AMC, in violation of American Mensa Bylaws, to restrict [the National Ombudsman] from having the same information as AMC members.” (4)

“Some members have mentioned perceived disparities between the current AML bylaws and the process of the [AMC].” (5)

Chairman Burg's “dismissive response to comments from concerned members, display[ed] an unfortunate lack of leadership on the part of the person who was elected to lead American Mensa.” (6)

Two proposed bylaws amendments address “problematic conduct on the part of the AMC.” (7)

### **Fix the National Office (NO)**

The NO has experienced:

“[a] steady loss of senior staff members under increasingly unpleasant circumstances... over-budget expenditures year after year...poorly-planned campaign roll-outs, increasing reliance on... paid outsourcing firms instead of Mensa volunteers” (8) and

significant flaws in the processes and practices necessary for maintenance

and upgrades to our technology systems. (9)

The Co-Chairs reported significant problems with NO staff and outside consultants while organizing the 2014 Boston AG. (4)

Despite this, Executive Director Donahoo was granted a salary increase.

### **In Conclusion**

Ultimately, we members are responsible for Mensa. The AMC and National Office staff are empowered – by us – to handle our money and conduct the business of Mensa. Our club is currently headed in a less-than-brilliant direction. The candidates and bylaws amendments you vote for will affect whether we continue along the same path or change direction. When we ask questions, we must insist on meaningful answers. An informed vote is an *intelligent* vote.
