Which **US President graduated from the Naval Academy in Annapolis**? We were pretty sure it was Jimmy Carter, until someone said, "Was it George H. W. Bush?" We agreed it SEEMED like it was Bush 41. It just seemed like the kind of thing he'd have done. We let knowledge win out over perception, and we were right. **Jimmy Carter graduated from the US Naval Academy.**

But is it really knowledge when it's trivia?

You'd be wrong if you think you have nothing to contribute. Ever been to Texas? Read a romance novel? Seen a James Bond film? Listened to pop music? We need you!

We meet at **6:15 p.m. every Thursday at Slow & Low Barbecue in Viera** for dinner, a cocktail, and scintillating conversation. Or just come for **Trivia at 7:00 p.m.** The whole SCAM-X team hopes you can join us!

In spite of its French name, **vichyssoise** is not “of Vichy”, but there is controversy about its origins. Julia Child calls it “an American invention”. Louis Diat, a French chef at the Ritz-Carlton in New York City, claimed its invention. Earlier, French chef Jules Gouffé created a recipe for a hot potato and leek soup, publishing a version in *Royal Cookery* (1869). The combination of pureed potatoes, leeks, and cream is hardly earth-shattering, and people have probably been making various versions of this soup for centuries, although Diat may have been the first to serve it intentionally cold. It is available in many restaurants and cafes, especially those with French pretensions. This is a standard recipe. There are many variations.

INGREDIENTS:

- 4 cups sliced leeks, whites only
- 4 cups diced potatoes
- 7 cups cold water
- 1½ to 2 teaspoons salt or to taste
- 1/2 cup or more heavy cream
- 1 tablespoon finely chopped fresh chives or parsley

METHOD:

Bring the leeks, potatoes and water to boil in a saucepan. Salt lightly, cover partially, and simmer 20-30 minutes, or until the vegetables are tender. Purée the soup in a blender. Chill thoroughly for several hours or longer. Top each serving with a sprinkle of chives or parsley.

This makes a delicious soup for summer, however the preparation time and effort involved make it unsuitable for a spontaneous lunch or dinner. I enjoy vichyssoise often during the hot summer months. So, how do I do it? I cheat! I keep in our refrigerator several cans of condensed potato soup. I empty a can in our blender, add a half a can of cold milk or cream, add a pinch or less of a spice, blend until smooth, and top each serving with a sprinkle of chopped parsley from my kitchen window herb garden.

Here's a quote from Bill Muckler, our Monthly Gathering speaker for October 10th...

"Imagine, in this high tech age of electronics and computers, stuff clogging up the system. Computers eventually become digital junk drawers. To unclog the clutter, one has to reboot, defrag or run disk clean-up to erase corrupted files on the computer. Keep the operating system. It works. Now imagine the United States of America as a computer hard drive and our Constitution/republic as a superior operating system. Clear out the political confusion and clutter of complicated oppressive taxes, excessive regulations and federal government junk, reboot and start afresh. Keep the Constitution. It works well."

I met Bill at a meeting of the Cocoa Beach Regional Chamber of Commerce. He's the author of a book entitled "20/20: A Clear Vision For America." Bill was there to promote his book which I have never read, but which I do intend to read. The reason I have not read Bill's book is because that way, I can keep an open mind and arrive at our Monthly Gathering with no preconceived notions about the material. By the way, I don't think that Bill is a politician. I think he is very likely a thoughtful and concerned citizen. He does not push a particular agenda, just asks you to please read his book and make up your own mind.

When people at the meeting asked Bill what his book was all about, I found it refreshing that Bill often asked probing questions rather than spewing information; questions that were like teasers on why you

The "Fine Print" for Calendar Events:

As a courtesy, notify the host if you plan to attend. Announced hosts should attend their events or arrange for a stand-in if unable. When reservations are required, you may not be able to participate if you fail to call.

Committee (AMC) scheduled for September 12, which will be long over by the time you read this. Unfortunately, due to newsletter deadlines, I can't provide the results of the meeting for this column, but I can mention the major agenda items. The first is a holdover from the July meeting, where a motion was presented to add an RVC to the Executive Committee (ExComm) of the AMC. It was postponed at that time, but there are good points on both sides of this issue. On one hand, the ExComm currently consists of the five nationally-elected officers, who have a legitimate claim to a mandate from the full voting membership of American Mensa. On the other hand, every voting member of the board, whether elected nationally or by a regional subset of the members, has the same fiscal responsibility for the organization. And RVCs have greater day-to-day interactions with local groups of all sizes and therefore have a better – or at least different – sense of the members' needs and preferences. There will undoubtedly be a spirited discussion of this motion.

Additional motions regard changes to the Name and Logo policies. One motion proposes creating special "Members of Mensa" logos and banners for use in events of members' choosing, allowing them to participate in political or socially-related events without suggesting that Mensa itself promotes or has any opinion on said event. I don't like this motion because while saying that the bearer of such a banner represents the members and not the organization may be technically true, it's a distinction that will be lost on outside observers, who will just see the logo on a banner and assume it represents a Mensa position.

At the same time, a companion motion is being made to add a final review to any Name and Logo Committee decision to make sure that new logos are not created that could be interpreted as taking a political or social position. The impetus for this motion was the creation of a logo earlier this year that placed the Mensa emblem on a rainbow background, to which some members have objected. This motion allows the Name and Logo committee to take into account factors beyond whether the proposed use meets the technical requirements of the policy, as this logo did.
